## HISTORICAL OVERVIEW

ÖSYM was established on November 19, 1974, under the name of “Inter-University Student Selection and Placement Centre (ÜSYM)”. In 1981, with articles 10 and 45 of Law No. 2547 on Higher Education, it was renamed as “Student Selection and Placement Centre (ÖSYM)”.

On March 3, 2011, Law No. 6114, which was published in the Official Gazette No. 27863, came into effect and the name was changed to Measurement, Selection and Placement Centre Presidency (ÖSYM).

ÖSYM is a special budgeted institution located in Ankara with administrative and financial autonomy, responsible for performing the assigned duties and exercising the authorities in accordance with the Law No. 6114 and Presidential Decree No. 4 on the Organization of Related, Affiliated Institutions and Other Institutions and Organizations published in the Official Gazette No. 30479 on July 15, 2018.

ÖSYM aims to be an internationally recognised testing centre that works together with all stakeholders. The organization’s fundamental philosophy is to be innovative, accountable, and reliable in its examination processes. Measurement, evaluation, and placement operations are carried out in a manner that ensures reliability, confidentiality, neutrality, and scientific principles, while also providing equal opportunities for all candidates.

To provide valid, reliable and fair measurement, selection and placement in the exams it administers.

## VISION

To conduct measurement, selection, and placement processes in accordance with international standards as an examination centre.

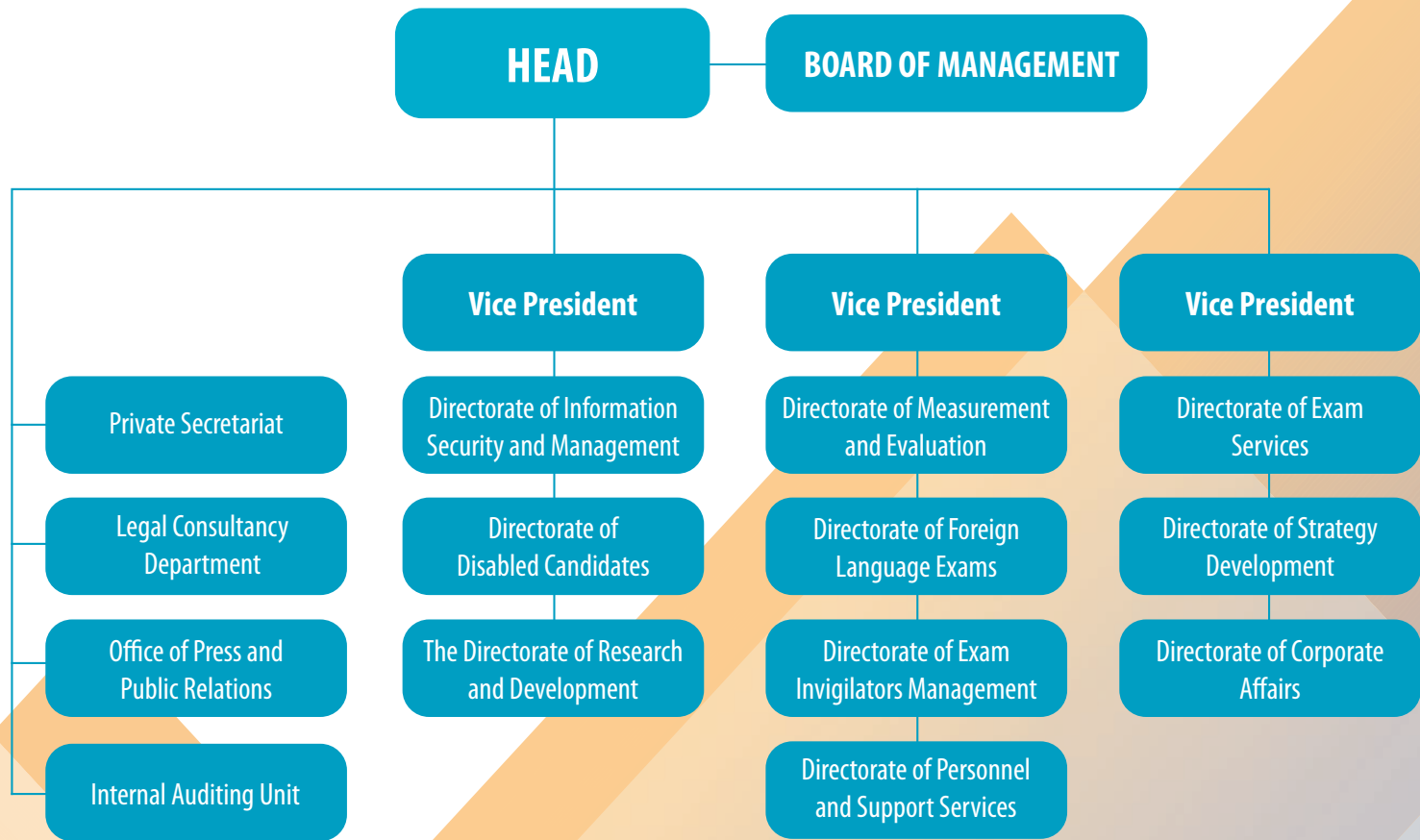
## DUTIES and AUTHORITIES

## CENTRAL PLACEMENT

Placement processes for students to be admitted to higher education institutions and for meeting the personnel needs of public institutions and organizations are conducted by the Student Selection and Placement Centre (ÖSYM). For this purpose, around 30 placement processes are carried out annually, primarily for student placement in higher education institutions.

## EXAM OFFICIALS

In order to maintain a high level of exam security and prevent possible grievances during exams, in addition to ÖSYM personnel, personnel from stakeholder organizations are also included in exam organization.

The organization of exams in exam centres, the transportation of exam documents to exam centres, the storage of these documents in exam centres, and the delivery of exam documents to exam buildings on exam day are carried out by individuals appointed by ÖSYM and ÖSYM Exam Coordinators. All personnel serving as exam building supervisor, assistant exam building supervisor, building administrator, exam room supervisor, and proctor in exam buildings and exam rooms are composed of faculty members from universities and administrators and teachers from schools affiliated with the Ministry of National Education.

5,995 population registry officials took part in the exams.



22,150 transfer couriers and 4,994 exam document protection officers have taken part.



36,922 disabled room attendants (readers, markers) have served.



7,571 prison officers (prison guards, prison teachers) have taken part in the exams.



189,286 police officers have taken part in the exam duties.



The exam with the highest number of examiners is the Higher Education Institutions Exam (YKS), in which a total of **859,287** people served.

## ELECTRONIC EXAMS (e-Exams)

e-Exams (Electronic exams) are administered on computers in Adana, Ankara, Istanbul, and Izmir e-Exam Centres in German, Arabic, Bulgarian, Persian, French, Italian, English, Spanish, Russian, and Greek languages.

Approximately 6,000 candidates take the exam at the same time in e-Exam Centres and the exam results are announced on the same day. Candidates are taken to fully secure e-Exam centres using biometric methods. Candidates enter the system by making identity number and face recognition verification in special cabins designated for them and start the exam.

Around 50,000 candidates participate in e-exams administered at ÖSYM e-Exam Centres at least once a month every year.

One of the biggest advantages of electronic exams compared to paper-based exams is that the results are announced on the same day, which speeds up the evaluation and result announcement processes.

In ÖSYM's 2022 exam calendar, there are a total of 14 electronic exams, including 13 electronic foreign language exams (e-YDS) held at least once a month and one e-YÖKDİL exam.

## ELECTRONIC EXAM CENTERS

As part of the integration of technological advancements into exam applications, it is aimed to increase the number of e-exam centres. The goal is to expand the e-exam applications that are currently being conducted in four regions to all regions of Türkiye and to increase the number of e-exam centres to at least 10.

## **EXAM CENTRES AND COORDINATIONS**

In Türkiye, there are 3 General Exam Coordinations, 91 Provincial Exam Coordinations, 111 District Exam Coordinations, and electronic exam centres where 6,000 candidates can take the exam simultaneously, in order to fulfill the principle of “for everyone, everywhere.” With the addition of the Overseas Coordinations in Northern Cyprus/Nicosia and Kyrgyzstan/Bishkek, the total number of coordinations reached 207 in the year 2022.



## FOR EVERYONE, EVERYWHERE

In line with the principle of “for everyone, everywhere,” efforts are being made to facilitate candidates’ access to exams. Services are provided in 81 provinces within Türkiye and also in Lefkoşa and Bıçkek through exam coordinations located abroad.

## EXAM APPLICATIONS FOR DISABLED CANDIDATES

In all exams, measures are taken to eliminate any inequalities that may arise for disabled candidates, either among themselves or in comparison to other candidates.

Exam practices and environments are prepared specifically for disabled candidates. Information related to the candidate's disability, such as question booklet reading/answer sheet marking, choice of exam room, access to the exam room, and the medications/materials that can be brought to the exam, are collected during the application process to ensure that disabled candidates can take the exam under conditions suitable for their disabilities. Additionally, based on the requests of disabled candidates, question booklets can be printed in different font sizes, additional time can be provided, and for electronic exams, screen readers and magnifiers are provided for visually impaired candidates. To ensure that exams are conducted in accordance with the established rules for individuals with disabilities throughout Türkiye, representatives from the Examination Center of Student Selection and Placement Center (ÖSYM) are sent to monitor the process.

Achieving equality among candidates in exam practices and measuring the knowledge and skills possessed by candidates, regardless of their disabilities, is considered an important goal. Collaborative efforts are being made with universities and other institutions to improve the exam processes.

In accordance with the Regulation on the Employment of Disabled Individuals in Public Service, the Disabled Public Personnel Selection Exam (EKPS) is conducted for the placement of disabled individuals in public institutions and organizations at the secondary education, associate degree, and undergraduate levels. In EKPS, tests suitable for the perceptual and learning abilities of disabled candidates are administered based on their disability groups.



## **FEE EXEMPTION FOR FAMILIES OF MARTYRS AND VETERANS**

No exam fees, application service fees, and placement fees are charged from veterans, as well as spouses and children of martyrs and veterans who apply for exams. In 2019, 25,761 people benefited from this service, while 37,179 people in 2020, 36,922 people in 2021, and 52,299 people in 2022.

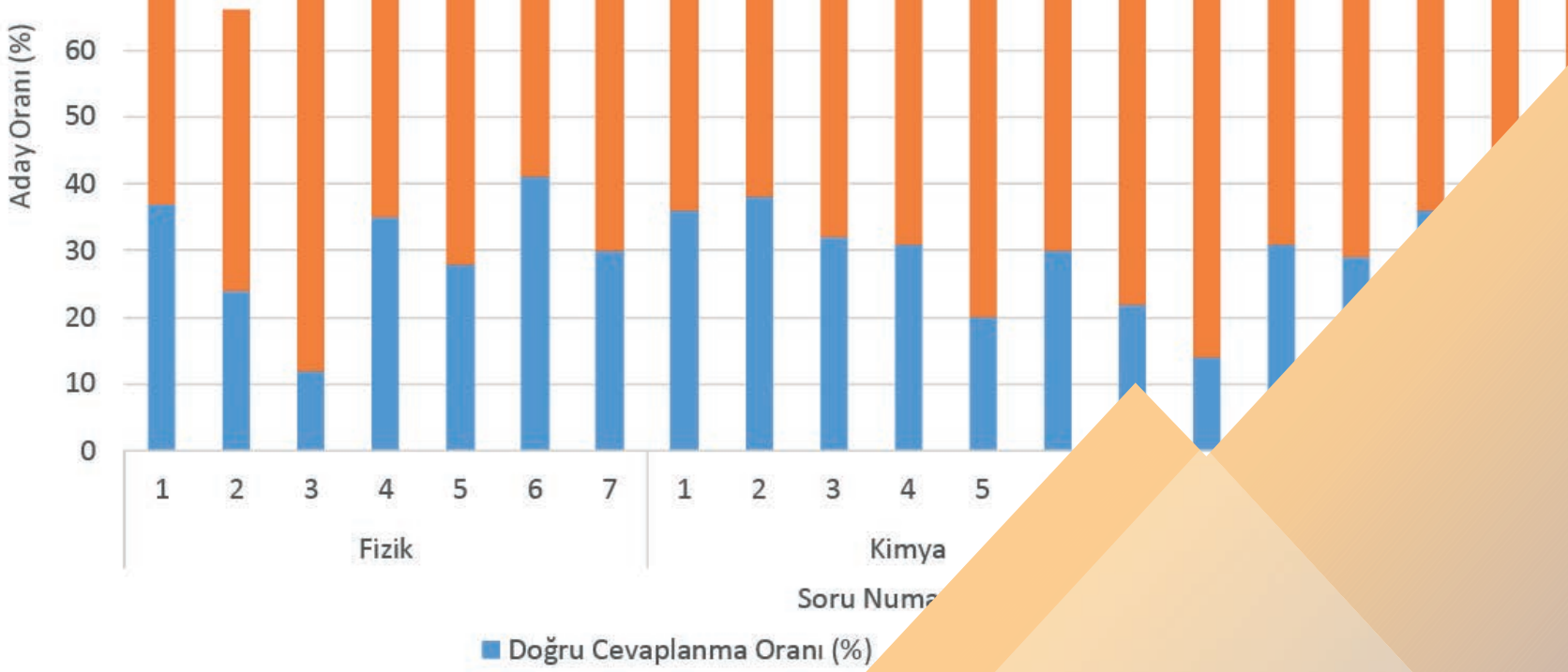

## QUESTION PREPARATION PROCESS

In the question preparation process, each question undergoes at least three domain checks. Questions are prepared by field experts and academics, and the prepared questions are reviewed by academics working in universities and public institutions. All of these processes are carried out on a computer system that is entered through palm scanning and does not establish an external connection. Questions are encrypted and stored in the question bank. Along with the preparation of the exam guide, five times the number of questions to be used from each field are loaded from the question bank to a cryptographic device through the password and palm scanning of the relevant deputy director and department head. The encrypted device is taken to the printing house according to a closed system of 24 hours, where the printing activities are carried out, and it is decrypted only with a password decoder used there. After the questions are decrypted, they are worked on again by the relevant field experts and academics before being transferred to the printing press. All personnel dealing with the questions remain in the printing house until the relevant exam is over. This period varies between 5 and 45 days depending on the type of exam. After the exam, the question publication process is carried out. The objections of the candidates to the questions are meticulously examined. At least three academics' opinions are obtained for each question objection, and the opinions obtained are sent to the ÖSYM Board of Directors for information purposes for a decision. After the necessary question objections are examined, the results of the exam are announced to the candidates.



## QUESTION GENERATION WITH ARTIFICIAL INTELLIGENCE (QGAI)

QGAI is a method that uses artificial intelligence models to generate questions and aims to teach human language to computers using natural language processing techniques.

QGAI first detects expressions in the source text that could be potential questions using NLP techniques. It produces the original and grammatically correct question text and creates answer options. Then, it generates the content of the question.

The stages during the activity period include: identifying the information to be asked a) grouping sources b) detecting information/keywords from the grouped texts, creating distractors a) vector similarity b) related terms in dictionaries, c) sentence completion methods; creating the question text.

A prototype of the automatic content generation framework has been developed from start to finish.

The machine learning model required for creating the question text step has been trained on sample datasets, experimentally generating questions and adapted to the framework.

Prototypes of modules for converting source books into text and grouping registered texts by similarity have been developed.

To integrate the QGAI system with the institution's infrastructure, interface modules have been developed using the FastAPI library in the Python environment. Classes for user and security codes have been defined for the developed interface's usage.





## FOUR SKILLS-BASED ENGLISH EXAMINATION

The increasing evidence for the dominance of Communicative Language Teaching and Learning Approach in foreign language education in the world and in Türkiye, and the need to meet the communication skills, require language assessment to focus on communication skills as well. In this context, ÖSYM, which is authorized to carry out measurement, selection, placement and evaluation tasks in education in our country, plans to apply and reflect modern developments in the measurement of English, which has become a global language worldwide. A computer-based exam that measures English based on reading, writing, listening, and speaking skills is being developed. The main purpose of this exam is to measure the proficiency levels in English, while meeting the highest validity, reliability, and security criteria and referring to the Common European Framework of Reference for Languages. This text provides a strong theoretical infrastructure and standardization opportunity for the definition of language skills in the context of the exam.

It is also believed that measuring English based on the four language skills will have a positive impact on language teaching and techniques in our country, as well as reflecting modern global theory and practice. Thus, it is expected that all four skills that make up language proficiency and their communication will be placed at the centre of language teaching and learning, rather than focusing on a single skill such as reading. The exam will also play a guiding role for candidates in their own language learning processes by allowing them to see and understand their strengths and weaknesses through its scientific result reporting system.

The Four-Skill Based English Exam being developed by ÖSYM, which measures at the B1-B2-C1 levels, is designed to reflect the most current academic, scientific, and technological developments from the creation of test specifications and parameter development to question pool development, exam application, exam scoring, exam analysis and evaluation, result reporting, and validity analysis. With its user-friendly interface and high standard validity, reliability, and security features, it will have a significant and valuable impact on English teaching, learning, and measurement in our country.



## FOUR SKILLS-BASED TURKISH EXAMINATION

In addition to the development of the Four Skills-Based English Exam, there is a growing need for teaching Turkish as a foreign language, both in the world and in our country, and for measuring the competencies of Turkish based on reading, writing, listening, and speaking skills. The increasing popularity of Turkish universities for foreign students and their preference, as well as the growing number of students learning Turkish in many countries abroad, necessitate the reliable, safe, and high-standard measurement of Turkish as a foreign language. In order to meet this need, the Four Skills-Based Turkish Exam is planned to be carried out.





## ÖSYM ACADEMY

ÖSYM Academy aims to respond to the needs of the time and emerging demands by conducting studies in line with the historical accumulation, vision, and mission of the ÖSYM Presidency and to improve its institutional capability. Training experts who are ethical, have expertise in their field, have the ability to use knowledge, are equipped for measurement, selection, and evaluation, and creating measurement standards are among the goals of the ÖSYM Academy. In this regard, certificate programs, educational studies, meetings, symposiums, conferences, seminars, etc. will be carried out.

### PROFESSIONAL COMPETENCE AND ACCREDITATION

Creating a quality and certification system for documenting the qualifications and achievements of the ÖSYM Presidency's employees with national and international accreditation is aimed. At the same time, ensuring sustainable institutional accreditation is among the top priorities.



## TÜRKİYE'S FOREIGN STUDENT ADMISSION EXAM (2023-TR-YÖS) CONDUCTED BY ÖSYM AFTER 13 YEARS

On January 29, 2023, Türkiye's International Student Admission Exam (2023-TR-YÖS) was applied by ÖSYM. The exam, aiming to standardize the acceptance of international students, was conducted in 6 different languages (Turkish, German, Arabic, French, English, and Russian) in a total of 27 exam centres including 17 cities in Türkiye and 9 countries including TRNC/NICOSIA.

# STRATEGIC PLAN AND DIGITAL TRANSFORMATION ROADMAP

## STRATEGIC PLAN

ÖSYM's strategic plan for the years 2024-2028, in which it sets realistic and sustainable goals and draws the roadmap in this direction, has been created with the contribution of all its components.

## ÖSYM DIGITAL TRANSFORMATION PROJECT 2023

ÖSYM Presidency has decided to start the "ÖSYM Digital Transformation Project" by evaluating its current situation and the goals it wants to achieve. The existing IT infrastructure of the Presidency, the existence of the "Information Security" culture, the previous studies on processes (ISO9001 and ISO27001), the readiness of the administrative units, the process-oriented work of the management, the awareness of the Presidency about data management are facilitating factors for the activities to be carried out.

ÖSYM, which continues its studies in line with the principle of zero error and maximum information security, conducts continuous exams throughout the year in line with the demands of institutions. For this reason, the digital transformation of ÖSYM should be controlled and managed with uninterrupted transitions. "ÖSYM Digital Transformation Project 2023" consists of five successive phases (PHASE I-V) in a way that will enable ÖSYM to achieve its goals more effectively/faster and more efficiently with a holistic transformation that brings together human, business processes and technology elements and enables a sustainable structural improvement.

In the first step (PHASE I), which will start the corporate digital transformation of ÖSYM, it is aimed to monitor intensive examination processes and design an expandable environment that will include an integrated quality management system (which will turn into a performance system, PHASE II). By ensuring the system security of the new platform (information security and system authorization management planning and digital monitoring, PHASE III), it is aimed to switch to automation (intelligent tracking and warning systems, PHASE IV) supported by artificial intelligence and deep learning algorithms. Finally, it is aimed to design and develop data mining and decision support systems on the "big data" to be obtained, to make analysis and conceptual improvements for the next steps of the transformation (PHASE V).

In this journey, which started with the slogan of "Digital Türkiye", ÖSYM Presidency has determined its goals and created the road map for the coming years. ÖSYM, which is the exam centre of Türkiye and conducts exams at international standards, will digitize the systems to measure the performance of each individual in line with these goals and will be higher than its current position.

As an institution that makes measurement, selection and placement with a valid, reliable, scientific, fair, transparent and innovative approach in the exams administered by the ÖSYM Presidency; It aims to ensure that the candidates complete the exam processes in the most suitable and comfortable conditions, to continuously increase the satisfaction in line with the expectations, and to increase accessibility with the principle of "Being Everywhere for Everyone". It carries out all its work within the framework of the authorities and responsibilities given by the relevant laws, regulations and other legal regulations, by taking scientific resources and authorities as a reference. It has determined as a quality policy to constantly renew itself in terms of exam technologies and to adapt to these technologies quickly, to be accountable, to comply with the conditions required by the management system with the participation of competent and authorized personnel, to ensure the continuous development and improvement of the management system.

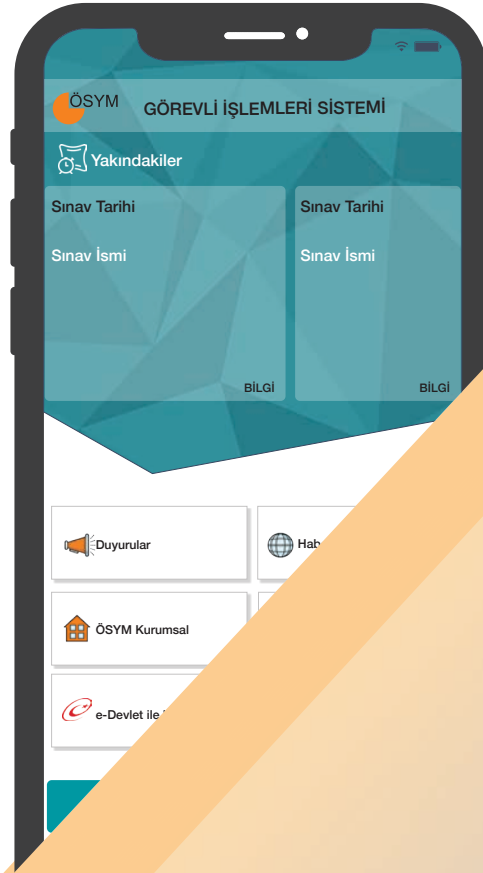
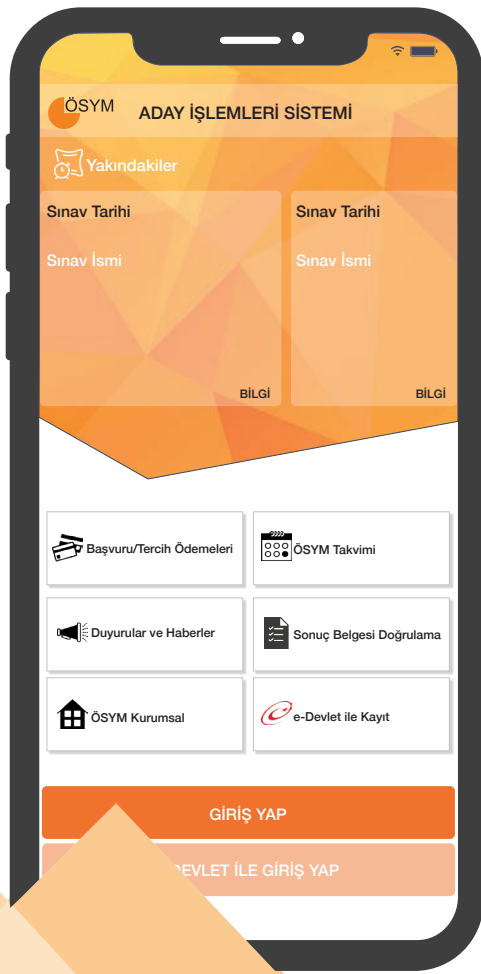
